Following investigations, I find that you are guilty of contravening the following Motorsport UK NCR(s):

Ch.12 App.7 Art.1.8 Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car (such as leaving the track) will be reported to the Clerk of Course and may entail the imposition of penalties up to and including the disqualification of any driver concerned.

### **Brief Details:**

Having received a written report from marshals post 4, Car 21 made contact with car 87 at turn 4 causing car 87 to spin. Both drivers were interviewed and in car video footage was viewed from both cars.

Version 2 - In accordance with NCR Ch.2 Art.1.23 this decision sheet is reissued to correct a clerical error. The penalty is changed because of clerical error and is now disqualified from the race and not the meeting, licence penalty points remain 4. The original decision sheet was issued at 16:21 on 10/08/2025 and posted on the official noticeboard at 16:27 on the same date.

NCR Ch.2 Art.1.23. Clerks of the Course and all Stewards have the authority to correct clerical errors in their Decisions after publication of the Decision provided that the meaning of the Decision is not thereby altered. The correction of such errors does not affect the commencement time of any Appeal period which shall remain as that applying to the original Decision.

Accordingly, under NCR Ch.5a App.5 Art.2.3, I hereby order that you receive the following:

Disqualified from the results of the race.  
Number of Licence Penalty Points: 4

You are reminded of your right of appeal. Any penalties applied will be recorded by Motorsport UK in accordance with the NCR.
