Reason(s) for this decision:
The Stewards endorse the Clerk of the Course's view that the circumstances in this case do not represent a case of force majeure as referenced within Article 41.4 of the Sporting Regulations. In reaching this decision, the Stewards have noted that the choice of which tyres to use during the Qualifying 1 session was down to the individual competitor, the track having been declared 'wet' by the Clerk of the Course. They also consider that the competitor is responsible for deciding the timing of their qualifying runs during the session and note that other teams complied with the requirement to complete two timed laps despite also starting on slick tyres and then changing to wet tyres.
