The driver stated he did not consider he had run over the scrutineer foot and he put his hand through the window to acknowledge the scrutineer, He was apologetic.


Myself, Laura, Jenson & Simon Hunt went over to scrutineering to see Martin, we discussed the event. Collin Wallace was also present.


