Following investigations I find that you are guilty of contravening the following Motorsport UK NCR:

Ch.12, App. 7, Art. 1.8 – Causing a collision and / or repetition of serious mistakes or the appearance of a lack of control over the Vehicle

Additional Information / Reasons for Decision / Evidence:

Marshal Report received at 13:45 from Race 1. (Race 1 finished at 11:51) involving Car 50 and Car 13. The driver of Car 50 was also attending the Medical Centre in the 30 minute period after the race finished.
Held judicial at the earliest opportunity.
The drivers of Cars 50 & 13 were interviewed and on-board footage from both cars reviewed.
Car 13 is considered to have caused a collision.
