Following investigations, I find that you are guilty of contravening the following Motorsport UK NCR(s):

Ch.12 App.7 Art.1.8 Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car (such as leaving the track) will be reported to the Clerk of Course and may entail the imposition of penalties up to and including the disqualification of any driver concerned.

## **Brief Details:**

Contact from front of car 92 with rear of car 51 T11-12, with 51 spinning.

Driver of car 92 states they were surprised by the point at which 51 braked in T11 and contact was made, and then contact continued however 92 was on and off brakes a number of times.

92 should have accounted for the points at which others may brake especially given this was a reverse grid race slower cars/drivers may have been ahead.
