Following investigations, I find that you are guilty of contravening the following Motorsport UK Regulation(s):

Q12.21.4 Repetition of serious mistakes

Brief Details:

Car 51 had multiple contacts with car 99 before turn 5 and car 51 had multiple contacts with car 38 between turns 8 and 11. Footage received from cars 51, 99 and 38. Driver of car 99 interviewed. Decision given to driver of car 51 via telephone as driver had left the circuit.

Accordingly, under Motorsport UK Regulation G 5.3, I hereby order that you receive the following:

Grid Place Penalty to be served at a future race, when that can be applied. Number of Licence Penalty Points: 3

Additional Comments: Car 51* to receive a 7 grid-place penalty

*Version 2 - In accordance with NCR C.2.13 this decision sheet is reissued to correct a clerical error, that being that the additional notes section incorrectly referred to Car 52 receiving a Grid Place Penalty, which should read Car 51, as stated in the opening details of this decision. The penalty is unchanged. The original decision sheet was issued at 15:19 on 19/05/2024, emailed to the competitor at 15:30 and posted on the official noticeboard at 15:59 on the same date.

C.2.13. Correction of Clerical Errors.
