Following investigations, I find that you are guilty of contravening the following Motorsport UK Regulation(s):

Q12.21.4 Causing a collision

Brief Details:

Car 28 made side to side contact with car 7 while making an overtake, car 28 maintained the position. After reviewing footage from car 28 and interviewing driver 28 and entrant of 7 driver of car 28 to be given 3 championship behaviour points resulting in a 5 place grid penalty for the next race as per championship regulation 4.2.4

Accordingly, under Motorsport UK Regulation G 5.3, I hereby order that you receive the following:

Additional Comments: Car 28 to be given 3 championship behaviour points resulting in a 5 place grid penalty for the next race as per championship regulation 4.2.4.

Version 2 - In accordance with NCR C.2.13 this decision sheet is reissued to correct a clerical error, that being that Car 28 made contact with Car 7, not Car 43 as incorrectly stated on the original decision document.
