Following investigations, I find that you are guilty of contravening the following Motorsport UK NCR(s):

Ch.12 App.7 Art.1.8 Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car (such as leaving the track) will be reported to the Clerk of Course and may entail the imposition of penalties up to and including the disqualification of any driver concerned.

Brief Details:

- 1) Entering The Hairpin (T14) car 90 made nose to tail contact with car 17, sending car 17 in to the side of car 119, which spun. Cars 17 and 119 retired.
- 2) Entering The Hairpin (T14) on the penultimate lap, nose to side contact was made with car 19, causing car 19 to run wide and lose several places. **all three cars involved in the above incidents sustained damage**
- 3) The driver of car 90 was unable to provide footage of these incidents.
- 4) These incidents followed two technical disqualifications yesterday whereby the driver stated he 'wasn't one to read the regulations'.
- 5) In discussion in relation to all of the above incidents, the driver did not seem overly concerned about receiving penalties and licence points.
- 6) In accordance with NCR Ch1 App1, the driver of car 90 is also disqualified from his races in the Modified Fords, in which he was racing a different car this weekend.

Evidence Relied Upon:

In car footage from cars 19, 17 and 119 regarding race 2 incidents.
Circuit CCTV footage regarding race 2 incidents.

Accordingly, under NCR Ch.5a App.5 Art.2.3, I hereby order that you receive the following:

Disqualified from the meeting.
Number of Licence Penalty Points: 6

You are reminded of your right of appeal. Any penalties applied will be recorded by Motorsport UK in accordance with the NCR.
