Following investigations, I find that you are guilty of contravening the following Motorsport UK Regulation(s):

C1.1.6, Q12.24.3 (e/f), Q12.24.5 Overtaking or not slowing down whilst yellow flags/lights were displayed.

Brief Details:

Report received of car 21 overtaking car 174 under double yellow flag conditions at Copse corner. Drivers of both cars were interviewed and onboard footage from cars 21 and 174 was reviewed.

The footage from car 174 shows that car 21 overtook after the incident at Copse but before the green flag at Post 19 (Copse exit), after passing a yellow light panel and single yellow flag at Woodcote, and a double yellow light panel and double yellow flag at Copse entry. The green flag at Copse exit was visible in the distance.

The footage from car 21 shows that the driver has gear selection issues approaching Woodcote. Car 174 passed car 21 prior to the first yellow light panel. Through Copse, car 21 starts to pull alongside car 174 approaching the incident, which is off track, on driver's left. Between the incident and the green flag, car 21 pulls fully alongside car 174 and completes the overtake.

Although the driver of car 21 was apologetic, there are no mitigating circumstances, therefore the guideline penalty applies.

Driver verbally informed of decision at 09:36hrs

Accordingly, under Motorsport UK Regulation G 5.3, I hereby order that you receive the following:

Addition of time to your race time.
Number of Licence Penalty Points: 3

Additional Comments: An addition of 0.554 seconds to be added to car 21 race time.

You are reminded of your right of appeal. Any penalties applied will be recorded by Motorsport UK in accordance with Motorsport UK Regulation C 2.1.4
