Following investigations, I find that you are guilty of contravening the following Motorsport UK Regulation(s):

C1.1.9 Abusive language or behaviour, physical assault, or threats of physical assault within the area under the control of the Organising Club.

Brief Details:

Hearing held at 17:56 on 13 October 2024.

Present: Paul Levitt, Andrew Roberts, Esther Crook, Luck Souch, Lucas Hayden (U-18), Richard Hayden (parent), Anita Hayden (parent), Simon Horrobin, Julie Neeves (partner of S Horrobin).

It was alleged that when Simon and Lucas were entering the clerks room for a judicial hearing after Race 2 of the event on 12th October 2024 that Julie Neeves used foul and abusive language in earshot of a minor and perceived to be directed at one of the individuals present.

A written statement from Richard Hayden was read out and asked to add any further comment.

Julie was asked for her account of the incident, and did state that she did use foul and abusive language but it was not directed at anyone particularly.

Simon stated that he did not hear anything when he entered the clerks office.

Lucas stated he brought this to the clerks attention due to ongoing aggressive behavior.

Hearing was adjourned at 18:05. Witness Sid Smith brought into room.

Hearing resumed: 18:06.

Sid Smith stated that he heard foul and abusive spoken by Julie as supplied in the written statement by Richard Hayden whilst outside the clerks office. Julie asked when this happened, and Sid Smith responded as Simon and Lucas and Richard were walking into the clerks office. Hearing adjourned: 18:08.

Reconvened 18:16.

Paul Levitt explained that the offensive words were spoken and not denied by Julie, and they were in the vicinity of a minor. There is a perception that this was directed at someone in the vicinity.

Under Section H 26.1.2 of Motorsport UK General Regulations Mr Horrobin is responsible for all acts of any person connected with the driver/entry.

Decision verbally issued to Mr Horrobin at 18:19. Meeting closed at 18:19.
