Following investigations, I find that you are guilty of contravening the following Motorsport UK NCR(s):

Ch.12 App.7 Art.1.8 Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car (such as leaving the track) will be reported to the Clerk of Course and may entail the imposition of penalties up to and including the disqualification of any driver concerned.

## **Brief Details:**

Contact was reported between cars 15 and 12 at Turn 1. Onboard footage from both cars reviewed and driver of car 15 interviewed. Footage from car 15 showed that the windscreen was badly fogged up and the driver had advised he'd tried to get into the pit lane on the previous lap but was unable to do so due to the proximity of another car.

Driver was very apologetic during the interview and acknowledged that they were at fault for the incident.

Given the obvious visibility problem and the driver's decision to continue for another lap, rather than pull off into a safe place, I deem this to be a serious error in judgement resulting in the contact.

Accordingly, under NCR Ch.5a App.5 Art.2.3, I hereby order that you receive the following:

Disqualified from the results of the race.
