Following investigations, I find that you are guilty of contravening the following Championship Regulation(s):

5.6.3 Tape covering rear bodywork joint line

## **Brief Details:**

Post-race report received from a judge of fact for eligibility (Clive Greves) of a contravention of Championship regulation 5.6.3 Bodywork, specifically Tape covering bodywork joint line at rear of car number 31.

5.6.3 [...] It is not permitted to cover bodywork apertures and joint lines with adhesive tapes unless authorised by the Eligibility Scrutineer as a short-term repair.

Hearing conducted with Scott McKenna entrant of MDD Racing, and driver Felix Livesey, with Luke Souch (Clerk of the Course). Clive Greaves (Eligibility scrutineer) was called as a witness.

Mr McKenna gave the reason for the tape being present on the bodywork at the rear of the car was due to consent being given by the scrutineers to do so during the event so far when the vehicle was inspected by scrutineers in the awning. Mr Greaves gave evidence and denied this permission was granted by an Eligibility Scrutineer as prescribed in the Championship Regulation 5.6.3 as a short-term repair.

## Evidence Relied Upon:

Technical Non-compliance report from Eligibility Judge of Fact, including photographs.

Accordingly, under NCR Ch.5a App.5 Art.2.3, I hereby order that you receive the following:

NCR Ch.2 App.8 Arts.2.1a+b - The event will still count as one of the events contributing to your total Championship score, and you will be disqualified from the event (race) forfeiting all Championship points, prize money and other awards.

You are reminded of your right of appeal. Any penalties applied will be recorded by Motorsport UK in accordance with the NCR.
