The appeal is upheld. The Stewards recognise the failure of car 97 to complete two timed laps as being a case of force majeure and determine that car 97 shall start the race from the grid the position calculated using the single lap time set by driver 1 in Qualifying 1 added to the best lap time set by driver 2 in Qualifying 2.							

Reason(s) for this decision:

The Stewards have considered the case presented by the competitor that their ability to complete two timed laps during the Qualifying 1 session was compromised by a technical issue which was outside their control. The competitor argues that this was the result of an error by a third party supplier which the regulations mandate them to use and which they had no opportunity to identify prior to the start of the session. The Stewards have seen written evidence from the supplier confirming the situation as described by the competitor. Accordingly, they recognise these circumstances as being a case of force majeure as referenced in Article 41.4 of the Sporting Regulations and determine that the setting of only a single lap time by car 97 should be accepted in this instance.
