- 2) I was not informed that I was under any sort of investigation.
- 3) I was not informed of the decision.
- 4) The series co-ordinator was also not aware of the above.
- 5) My first knowledge of this situation was when I opened my emails on Sunday evening.

I believe I have data logger and video evidence that shows I was just caught up in racing incident that was happening to the two cars in front of me. I was not to blame for the incident. I wish to able to present this evidence so the Judicial process is fair and just.
