Following investigations, I find that you are guilty of contravening the following Motorsport UK NCR(s):

Ch.12 App.7 Art.1.8 Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car (such as leaving the track) will be reported to the Clerk of Course and may entail the imposition of penalties up to and including the disqualification of any driver concerned.

Brief Details:

Exiting turn 13 side to side contact occurred between cars 83 and 55, after 55 went around outside of car 83 to pass. Car 55 appears to drift to left and 83 also had space on left and contact occurred, with 55 pitched into slight drift. 83 passes 55 back at turns 14 and 15 and defends into turn 16, car 55 then makes contact with rear of 83 and 83 subsequently is pushed wide. 55 retakes the position.
Under interview driver of car 55 stated they felt car 83 collided into them, and it is the opinion of the clerk of the course that the subsequent contact at turn 16 was in response to the incident at the exit of turn 13.
Car 95 was following and contact was made with 83 following this - subject to separate decision sheet.

Evidence Relied Upon:

Onboard footage from cars 55, 83 and 95.
Interview with drivers of cars 55, 83 and 95 with team representatives.

Accordingly, under NCR Ch.5a App.5 Art.2.3, I hereby order that you receive the following:

Grid Place Penalty to be served at a future race, when that can be applied.
Number of Licence Penalty Points: 3

Additional Comments: 3 grid place penalty.

You are reminded of your right of appeal. Any penalties applied will be recorded by Motorsport UK in accordance with the NCR.
