Following investigations, I find that you are guilty of contravening the following Motorsport UK NCR(s)

Ch.12 App.7 Art.1.8 - Causing a collision, repetition of serious mistakes or the appearance of a lack of control over the car (such as leaving the track) will be reported to the Clerk of Course and may entail the imposition of penalties up to and including the disqualification of any driver concerned.

### **Brief Details:**

On final lap, car 27 was baulked by slower GTA class car, with 51 gaining greater speed advantage onto Hangar Straight. Between Turns 6 and 7 two instances of side to side contact occurred with 51 contacting 27 when initiating the pass.

27 then made movements to left and contact again occurred between the two cars.

At turn 7, car 27 had position on inside and contact again occurred with 51 front right contacting 27 rear left. 27 then pitched into slide and ran wide, further contact occurred off track exiting Turn 7.

Both drivers warned about their future conduct.

Driver of 27 penalised for their part in this series of avoidable contacts.

### **Evidence Relied Upon:**

Onboards of cars 27 and 51.

Interviews with drivers of cars 27 and 51 with team representatives

Accordingly, under NCR Ch.5a App.5 Art.2.3, I hereby order that you receive the following:

Verbal Warning

You are reminded of your right of appeal.
