Following investigations, I find that you are guilty of contravening the following Motorsport UK NCR(s)

Ch.12 App.7 Art.1.5.f - Manoeuvres liable to hinder other Drivers such as deliberate crowding of a Vehicle beyond the edge of the Track or any other abnormal change of direction

Brief Details:

Report received of car 24 crowding car 64 onto the grass on Starkey's Straight.

Drivers of both cars interviewed and onboard footage reviewed. The onboard from car 64 appears to show that car 24 made two distinct moves to the right hand side of the track as car 64 was pulling alongside car 24. The footage from car 24 showed minor contact with the rear of car 91 exiting Coppice corner. Car 24 then pulled alongside car 91 with the driver looking to the left and giving a wave of apology. As this happens, car 64 is starting to pull alongside car 24, as described above. Driver of car 24 does not appear to make any abnormal or erratic steering input, nor do they appear to look into the right hand side wing mirror as they move across to the right hand side of the track, until car 64 is alongside and on the grass.

Based on the evidence available, I believe that car 24 could have done more to avoid the incident but it was, in my opinion, an error rather than a deliberate act, which is reflected in the penalty decision.
